Sailing School: Navigating Science and Skill, 1550-1800 (Johns Hopkins University Press, 2019). This monograph compares the development and dissemination between ca. 1550 and 1800 of Spanish, Dutch, English, and French sailors’ navigational practices—in the classroom, on board ship, and across international borders. This book highlights the technical contributions of this startlingly multinational community, and in turn, contextualizes the place of instruments and visual culture in the circulation of technical knowledge during the Scientific Revolution.

Works in Progress

A Floating Academy: Commerce and Calculation in the Age of Sail.

This second book-length project centres on the *Prince de Conti*, a French merchant ship that embarked on a trading venture to India in 1754. It draws upon a cache of archival documents fortuitously preserved in the midst of

the Seven Years War. In addition to revealing new insights into the everyday lives of the sailors, merchants, and family members who were caught up in the trade and conflict of the period, this particular archive contains a significant collection of mathematical documents. These ink-spattered student worksheets, hand-copied textbooks, and records of mid-voyage observations and computations, provide unparalleled evidence of how complex new mathematics was not only taught but also applied at sea. Taken together, they offer a rare glimpse into the type of collaborative mathematical work that took place on a true “floating academy” in the Age of Revolution.
